Environmental Services Superintendent reported on his department's operations for January which included G3 pretreatment, a petroleum issue at Jonesy's Travel Center affecting the Wastewater Treatment Plant, DNR well inspections, the Frank Street water line replacement, rock blasting the Lebanon Industrial Park, and the LTCC Jamboree his department participated in.

Electric Superintendent Travis Long reported that his department was finishing up a new 3 phase service for MFA as well as upgrades to other 3 phase services and installing new controls on their capacitor banks which would provide more data and report back on the SCADA system. He also shared the electric outage comparison from 2022 to 2023 and stated wildlife was the leading cause for outages.






PRODUCTION
