COMMENTS

Fire Chief Sam Schneider- provided information regarding staffing of his department, which included that a job had been offered to the first candidate who would go through training at Springfield Fire Academy while being actively employed with the City. He closed by thanking the Mayor, Council, and City Administrator for being supportive of his department and making sure they had the equipment and apparatuses needed.

Parks Director John Shelton- reported that the Tree City signs had been installed, the restrooms at the parks would be open by the end of the week, and the opening day for the pool would be June 1st.

Councilman Ray- stated he had sent out an update about the skatepark to the Mayor, Council and Parks Director John Shelton and shared that his participation in this process had been a good experience. Shelton then reported he would be presenting the information regarding the skatepark at an upcoming work session and then to the Park Board for their approval.

Councilwoman Mitchell- asked about Farmers Market as a follow up to comments made earlier in the evening during public comments Staff reported that the City had a lease with Farmers Market while City Counselor Chris Allen said that the City was merely a landlord and their issues would have to be resolved among themselves.

Councilman Eldridge- commended Fire Department personnel for their quick response time and professionalism during his recent emergency event.

Councilman Adkins- asked if the plaque honoring former Councilman Bill Wheeler for his work on Route 66 projects had been installed at Boswell Park. Parks Director John Shelton reported that it had been, and it looked good.

Mayor Carr- commended the LHS Girls Wrestling Team for their second State title. He then provided the upcoming meeting schedule and reminded everyone of the General Municipal Election that would be held on April $6^{\rm th}$.
