

CITY OF LEBANON
BOARD OF PUBLIC WORKS MEETING MINUTES
APRIL 17, 2024

BE IT REMEMBERED that the Board of Public Works of the City of Lebanon, Missouri, met on April 17, 2024, at 12:00 p.m. in the Meeting Room at the Public Works Facility located at 1401 West Commercial.

ROLL CALL AND DECLARATION OF A QUORUM

Upon roll call, the following Officers were present: Don Anderson, Ted Dahl, Jeremy and Goforth. Absent: LeAnn Mather.

A quorum was declared.

Jeremy Goforth acted as Chairman in the absence of LeAnn Mather.

Staff members and others in attendance: Public Works Director/Board of Public Works General Manager Richard Shockley, Electric Superintendent Travis Long, Environmental Services Superintendent Eric Mork, Public Works Analyst Kelly Roberts, Finance Director Kat Gill, and Assistant City Administrator/City Clerk Laina Starnes.

PUBLIC COMMENTS

APPROVAL OF MINUTES

Dahl moved and Anderson seconded that the Board approve the March 6, 2024, meeting minutes as presented. Motion carried as follows: Yea: (3) Anderson, Dahl, and Goforth; Nay: (0) None; Abstain; (0) None; Absent: (1) Mather.

PUBLIC HEARINGS

Anderson moved and Dahl seconded that the Board move out of Regular Session and into Public Hearing. Motion carried as follows: Yea: (3) Anderson, Dahl, and Goforth; Nay: (0) None; Abstain; (0) None; Absent: (1) Mather.

Utility Rates Schedule and Fees Schedule

Public Works Director/Board of Public Works General Manager Richard Shockley provided the FY2025 proposed rate and fee schedule for the Board's consideration. He stated the 2022 Cost of Service Study plus material costs were used for the proposed rate increased for electric and water; sewer rates would remain the same. During his presentation he shared that electric material costs had increased by 202%, water material costs had increased by 300%, while the City's wholesale cost had remained flat. Shockley also showed costs comparisons with other communities which reflected the City of Lebanon's utility rates were ranked lowest or near lowest.

There were no public comments.

Fiscal Year 2025 Budget

Finance Director Kat Gill presented the utility budget to the Board. During her presentation, she spoke about the City's Certificates of Participation (COPs), which is debt paid out, capital leases, and a repayment to the City's electric reserve for a past loan to Detroit Tool Metal Products. She also touched on fund balance requirements, revenue and expenses for each utility fund including capital, and rate schedules per fund, again mentioning there was no proposed sewer rate change for FY25.

There were no public comments.

Operations Update

Electric Superintendent Travis Long reported about the effects of the recent storm. He stated the City was spared and attributed it to their active tree trimming program. However, Long reported his department was asked to provide mutual aid to Wayneville.

Environmental Services Superintendent Eric Mork also reported that his department assisted with a plugged main sewer line the previous week at Bennett Spring.

February 2024 Operations Detail Report

Electric Superintendent Travis Long and Environmental Superintendent Eric Mork spoke briefly regarding on their monthly operations.

Finance Director Kat Gill went through the financials with the Board and highlighted the health of the fund balances.


Acting Chairman Goforth declared Resolution No. 2024-009 duly passed and approved.

Chairwoman Mather declared the meeting adjourned at 1:30 pm. Motion passed unanimously.

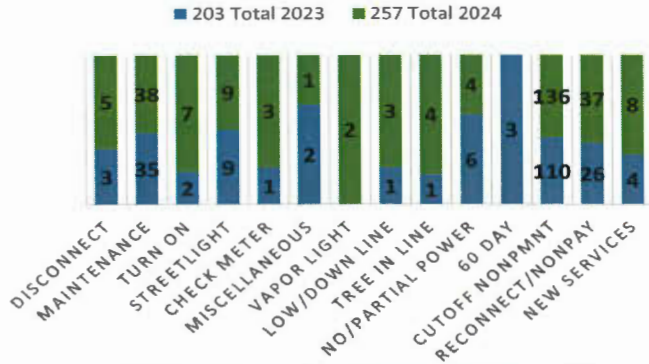

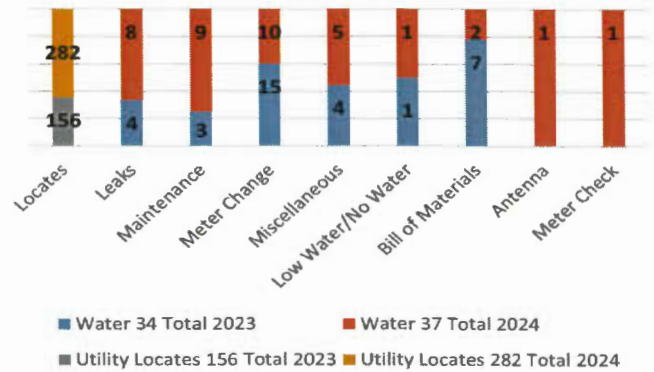
Operational Update February 2024

Environmental

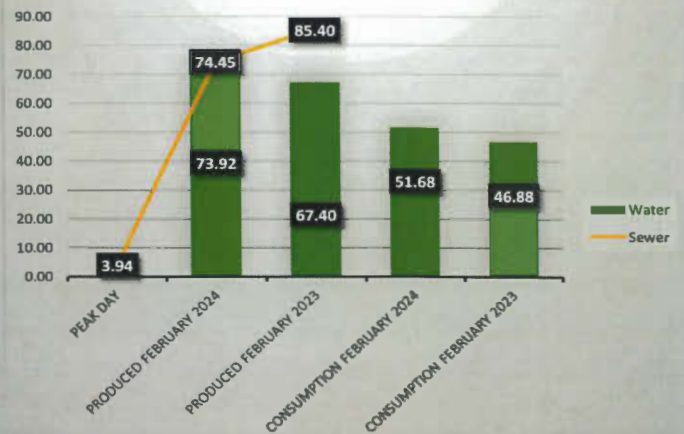


PRODUCTION
