CITY COUNCIL WORK SESSION MINUTES
May 13, 2024

BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Work Session on May 13, 2024, at 6:00 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

ROLL CALL AND DECLARATION OF A QUORUM

Upon roll call, the following Officers were present: Gib Adkins, Mike Evans, Sheila Mitchell, Dan Mizell, Jeff Mutchler, Randy Wall, Chuck Jordan, Bob Garner, and Mayor Carr. Absent: None.

A quorum was declared.

COUNCIL GOALS GROUP 2- INFRASTRUCTURE AND UTILITIES

Public Works Director Richard Shockley provided information related to their assigned goals. During this time, Shockley advised the Council that the City was partnering with Lebanon Special Road District to paint the edges of Gateway all the way to Hwy AA. Since the Goodwin Hollow Bridge would be under construction for several months beginning the first part of June, it was felt that many locals would use this road as a detour around the construction. He also mentioned that lights were being installed at the intersection of Gateway and Rolling Hills Road. Street Superintendent Mike Moore also spoke and specifically addressed speed limits because of concerns voiced by a few Councilmembers. He said that speed limits were not arbitrary and were set based on a number of traffic standards. He said speed zones should be consistent with prevailing conditions along the street such as stopping sight distance and sight triangles.


ROUND TABLE DISCUSSION
