CITY COUNCIL MEETING MINUTES  
July 22, 2024

BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Regular Session on July 22, 2024, at 6:30 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

An Ordinance by the City Council of the City of Lebanon, Laclede County, Missouri, (hereinafter referred to as "City") amending the City Code of Ordinances Chapter 44 Traffic and Vehicles Article VII All-Terrain Vehicles and to enact newly created Articles X and XI to address Utility Vehicles and Golf Carts.

An Ordinance by the City Council of the City of Lebanon, Laclede County, Missouri, (hereinafter referred to as "City") amending the City Code of Ordinances Chapter 44 Traffic and Vehicles, Article V Stopping, Standing and Parking, Section 44-467 Prohibited Stopping, Standing and Parking Areas Enumerated to address parking in front of mailboxes.

**COUNCIL BILL NO. 6723- AGREEMENT, PROPANE TO VARIOUS CITY FACILITIES THROUGH JUNE 30, 2025, MFA OIL**

An Ordinance by the City Council of the City of Lebanon, Laclede County, Missouri, (hereinafter referred to as "City") authorizing and directing the Mayor Pro Tem and City Clerk to enter into and execute an Agreement with MFA Oil to provide Propane to various City Facilities through June 30, 2025.

COUNCIL BILL NO. 6724- CODE AMENDMENT, AMENDING CHAPTER 28 ARTICLE VI SECTION 28-363 AND TO ENACT A NEWLY CREATED ARTICLE VIII TO ADDRESS HUNTING REGULATIONS WITHIN THE CITY OF LEBANON

An Ordinance by the City Council of the City of Lebanon, Laclede County, Missouri, (hereinafter referred to as "City") amending the City Code of Ordinances Chapter 28 Offenses Article VI Offenses against Public Safety Section 28-363 and to enact a newly created Article VIII to address Hunting Regulations within the City of Lebanon.

Jordan moved and Wall seconded that the Council approve the first reading of Council Bill No. 6724 and that it be passed to the second reading. Motion carried as follows: Yea: (6) Wall, Jordan, Garner, Adkins, Evans, and Mizell; Nay: (0) None; Abstain: (0) None; Absent: (2) Mitchell and Mutchler.

The second reading is scheduled for August 12, 2024.

Mayor Pro Tem Garner announced that the next meeting would be held on August 12<sup>th</sup>.


