BOARD OF PUBLIC WORKS MEETING MINUTES
October 2, 2024

BE IT REMEMBERED that the Board of Public Works of the City of Lebanon, Missouri, met on October 2, 2024, at 12:00 p.m. in the Meeting Room at the Public Works Facility located at 1401 West Commercial.

DISCUSSIONS AND PRESENTATIONS

Operations Update

Electric Superintendent Travis Long reported on his department's current and completed projects as well as provided outage information. With regard to outages, he reported there were 88 total outages in 2023 with over 50% of those due to wildlife. He advised that wildlife outages would happen over the next several months as squirrels were more active preparing for the winter. In an effort to inform the public, Long stated that Communications Manager Derek Gean was rolling out a social media campaign to educate the citizens about how much wildlife impacts electric infrastructure.

Environmental Services Superintendent Eric Mork reported on his department's activity as well. Mork spoke about the status of their smoke testing, water line replacements, and lead service line inventory, which was due October 16th.


Chairwoman LeAnn Mather declared Resolution No. 2024-022 duly passed and approved.
