Clean the street and right-of-way of any excess excavated material. If any grass has been disturbed, repair with 4" of topsoil, remove all rocks over 1" install grass seed and straw.

### **☐ Curb Cut:**

It is the owner's responsibility to saw cut the curb, remove all excavated material, supply and reinstall with 1" base rock and reinstall concrete curb per City of Lebanon specifications. Clean the street and right-of-way of any excess excavated material. If any grass has been disturbed, repair with 4" of topsoil, remove all rocks over 1" install grass seed and straw.

### **☐ Sidewalk Cut:**

It is the owner's responsibility to saw cut the sidewalk, remove all excavated material, supply and reinstall with 1" base rock and reinstall concrete sidewalk per City of Lebanon specifications. Clean the street and right-of-way of any excess excavated material. If any grass has been disturbed, repair with 4" of topsoil, remove all rocks over 1" install grass seed and straw.
