

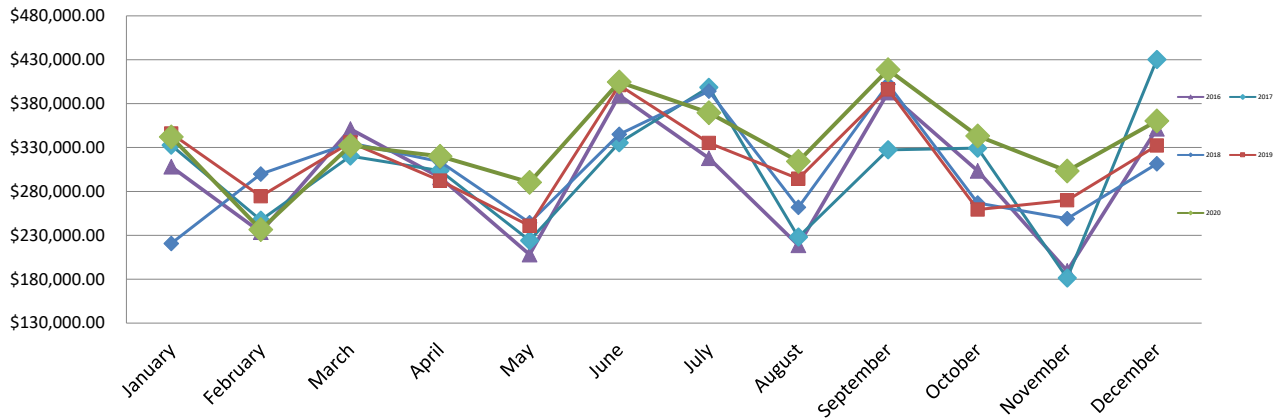

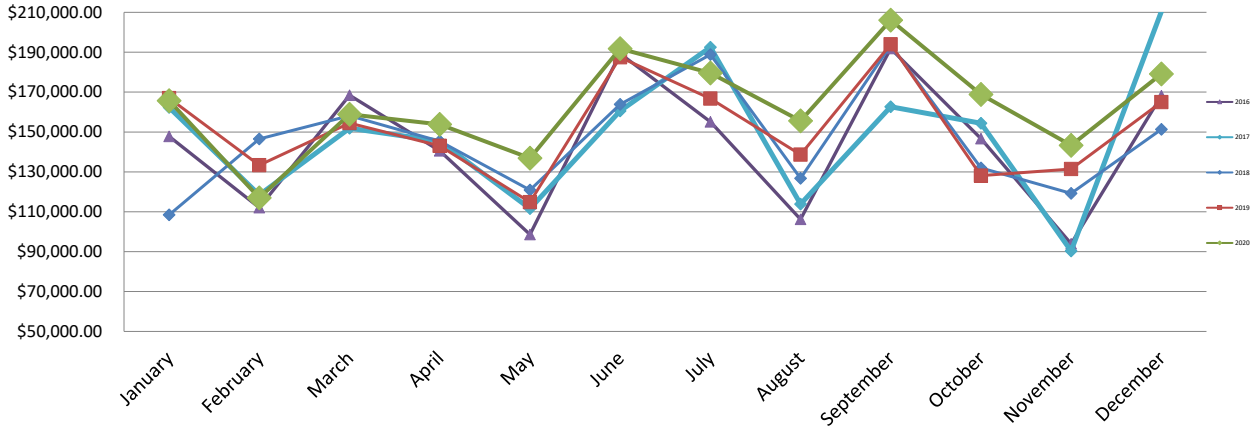

Transportation Tax - 1/2 %



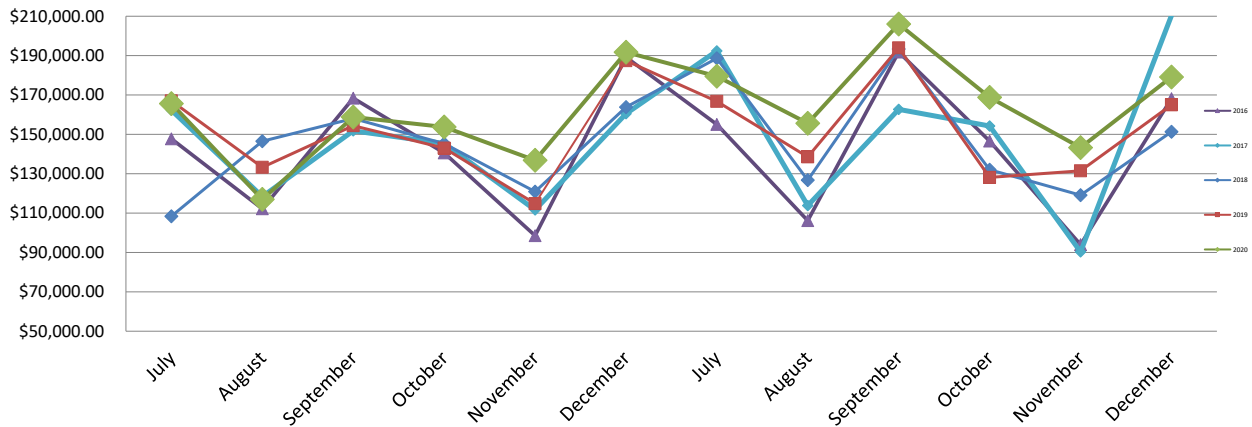
