



City of Lebanon Electric Vehicle Charger Rebate (EVCR) Application

A rebate (credit on account) is available to City of Lebanon residential electric customers installing a Level 2 charger for the purpose of charging electric vehicles. Retrofits and new construction are eligible as outlined in the EVCR

Residential (current and existing): Level 2 charger rebate of 50% of the cost up to \$250 .

Residential (new construction only): A \$150 rebate is available for residential new construction to install (1) 240V NEMA outlet located in an enclosed garage or at a residence located within 10ft of dedicated parking space, with a maximum of (1) outlet per household.

☐ **Paid Receipts:** Application must be submitted with a copy of the paid receipt that lists the model numbers for the system along with other applicable receipts.

☐ **Permits:** A copy of the complete electrical permit from Community Development of the City of Lebanon, Missouri, is required. These permits are usually obtained by the contractor.

☐ **Deadlines:** The rebate application form and receipts must be submitted within 90 days of purchase and installation date. Rebates will be awarded to complete and accurate applications while funds remain available.

☐ **Verification:** The City reserves the right to inspect the installed equipment before the rebate account credit is issued.

Guidelines

- 1. Application must be submitted within 90 days of purchase and installation date.**
2. The applicant must be the customer of record for an active, non-delinquent account.
3. All Level 2 EV chargers must be new.
- 4. The installation must include a minimum of a 50-amp branch circuit equipped with a NEMA 6-50 or NEMA 14-50 receptacle to accept a Level 2 EV charger. Hardwiring the charger is acceptable.**
5. EV home upgrade must be installed by a professional licensed electrical contractor in accordance with City of Lebanon regulations.
6. If new construction, the EV-ready home outlet must be installed during the building process, and be connected and operational prior to occupancy.
- 7. Copies of installer itemized invoice and/or purchase receipt must be submitted along with a completed rebate application form.**
- 8. By receiving this rebate, the customer agrees to enroll in a Time of Use rate or demand response program when made available by the City of Lebanon.**
9. Failure to provide required information may result in denial of the rebate.
10. Rebates are awarded on a first-come, first-served basis until program funds have been depleted.
11. The applicant agrees that work completed complies with all federal, state, and local safety, building, electrical, and environmental codes. All necessary permits and/or inspections are the responsibility of the customer.
12. City of Lebanon is not responsible for the performance of the outlet or charger, and does not provide any warranties, expressed or implied.
13. City of Lebanon reserves the right to inspect the installed rebated premise and equipment. If the premise does not have the qualifying equipment installed, the rebate may be denied.
- 14. City of Lebanon reserves the right to amend or discontinue this program without notice.**
